## RULES AND REGULATIONS FOR STOCK CLASS (ONLY)

The following rules and/or regulations set forth herein are designed to provide for the orderly conduct of the Washington Jaycees Demolition Derby and to establish minimum acceptable requirements for such events. These rules shall govern the condition of all events, and, by participating in these events, all participants are deemed to have complied with these rules. No express or implied warranty of safety shall result from publication of or compliance with these rules warranty of safety shall result from publication of or compliance with these rules and/or regulations. They are intended as a guide for the conduct of the sport and are in no way a guarantee against injury of death to participant, spectator, or official. The Jaycee Race Officials shall be empowered to permit minor deviation from any of the specifications herein or impose any further restrictions that in their opinion do not alter the safety factor. Any interpretation or deviation of the rules is left to the discretion of the Jaycees Race Officials, and their decision is final. Jaycee Race Officials reserve the right to approve and/or reject all entries.

### PARTICIPANT ENTRIES:

- A. An entry fee will be charged for each car.
- B. All persons **MUST** sign entry form, insurance waiver, and release form, and purchase pit pass before entering pit area. A sample of a waiver and release form is printed on the reverse side of this sheet. All drivers and pit men will be required to sign it or one similar before entering pit area. **PLEASE TAKE THE TIME TO READ IT!**
- C. No one allowed in race area under the influence of liquor. **POSSESSION OF ALCOHOLIC BEVERAGES IN THE PIT AREA WILL RESULT IN LOSS OF PIT PASS AND EXPULSION FROM THE PITS.**
- D. All drivers **MUST** be 16 years or older, and **MUST** be able to provide proof of age at the request of Jaycee Race Officials. Drivers 16 and 17 years old **MUST** have parents or guardian sign minor waiver and release form. **NO EXCEPTIONS.** No one under the age of 16 will be allowed to drive or be in the pit unless a valid picture ID is shown.

### AUTOMOBILE & RACING REGULATIONS:

- A. Boat gas tank must be mounted in back seat. No more than 6 gallons of gasoline is allowed
- B. All glass must be removed from car.
- C. No imperials.
- D. Starter is allowed to be put on the dash, and the shifter is allowed to be put on the floor.
- E. All cars must remain in stock position including tires and rims.
- F. Two pieces of 1/4" wire is allowed to be used anywhere on car. Use wisely. Wire is not provided.
- G. Must have factory seat belts.
- H. Must wear helmet, shoes, pants and shirts.
- I. Any racer may look at any car at any time as long as the driver of that car is present. (If you are not cheating you have nothing to hide.)
- J. Minor trimming of fenders allowed and the frame can be notched No reinforcing is allowed. No nuts or bolts are allowed either.
- K. Motor mounts cannot be chained to the frame.
- L. Doors may be welded and have one reinforcement bar behind seat.

### RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration of being permitted to compete, officiate, observe, work for, or participate in any way in the EVENT(S) or being permitted to enter for any purpose any RESTRICTED AREA (defined as any area requiring special authorization, credentials, or permission to enter or any area to which admission by the general public is restricted or prohibited), EACH OF THE UNDERSIGNED, for himself, his personal representatives, heirs, and next of kin.:

1. Acknowledges, agrees, and represents that he has or will immediately upon entering any of such RESTRICTED AREAS, and will continuously thereafter, inspect the RESTRICTED AREAS which he enters and he further agrees and warrants that, if at any time, he is in or about RESTRICTED AREAS and he feels anything to be unsafe, he will immediately advise the officials of such and will leave the RESTRICTED AREAS and/or refuse to participate further in the EVENT(S).
2. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the promoters, participants, racing associations, sanctioning organizations or any subdivision thereof, track operators, track owners, officials, car owners, drivers, pit crews, rescue personnel, any persons in any RESTRICTED AREA, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the EVENT(S), premises and event inspectors, surveyors, underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENT(S) and each of them, their directors, officers, agents and employees, all for the purposes herein referred to as "Releases", FROM ALL LIABILITY, TO THE UNDERSIGNED, his personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
3. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releases and each of them FROM ANY LOSS, LIABILITY, DAMAGE, OR COST they may incur arising out of or related to the EVENT(S) WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
4. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the EVENT(S) whether caused by the NEGLIGENCE OF RELEASES or otherwise.
5. HEREBY acknowledges that THE ACTIVITIES OF THE EVENT(S) ARE VERY DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of THE UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.
6. HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the Releases, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of Province or State in which the Event(s) is/are conducted and that if any portion thereof is held invalid it is agreed that the balance shall, not withstanding, continue in full legal force and effect.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW. AFTER READING THE ABOVE RULES & REGULATIONS INCLUDING RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT YOU MUST FILL OUT AND SIGN THE FORM ON THE BOTTOM OF THIS SHEET.
